

THE HALDUN ALAGAS KARATE TRAINING CAMP

INDEMNITY AND CONSENT

PREAMBLE:

The Haldun Alagas Karate Training Camp (The Training Camp) will be held in **Bloemfontein** from **28 March 2011** to **1 April 2011**.

Given the nature of the sport of karate and the physical activities which participants will engage in during the course of the Training Camp, there exists a risk of serious bodily injury, including permanent disability, paralysis and death ("Risks")

Although The Training camp will be conducted in a controlled environment under the supervision of Very experienced instructors, these Risks may be caused by the participant's own actions, or inactions, the actions or inactions of others participating in the training camp, pre-existing medical conditions or the negligence of the organising staff referred to herein below.

Given the number of participants, spectators, organisers and support staff, there is a risk of loss, theft or damages of personal property, whether it be through negligence or wilful conduct.

By signing this consent and indemnity, the participant or the participant's father/ mother/ guardian*

*(delete whichever is not applicable)

warrants that:

the participant is in good health and sound mind and there is no known reason, medical or otherwise why the participant cannot participate in the Training Camp;

[If necessary, the participant or the participant's father/mother/guardian* has or will discuss participation in the training camp with a doctor]

consent was given freely and voluntarily;

he/she was capable of volition;

had full knowledge of the extent of possible prejudice;

realise and appreciate fully the nature and extent of the possible harm.

INDEMNITY AND CONSENT:

the **organisers** of the Haldun Alagas Karate Training Camp (The Training Camp), including but not limited to **coaches, instructors, administrative staff or any other party involved** in any way with the event (the organisers) , from any death, injury or disability and all claims, causes of action, losses, damages, costs, expenses (including but not limited to attorney's fees), either known or unknown, now existing or arising in the future that I may have of whatever kind or nature, which I/my child mentioned below* may suffer as a result of my/his/her* participation in the Training Camp (including but not limited to training, leisure time utilisation and /or any related activity to the Training Camp)

I further agree that any photographs, motion pictures, recordings or any other record taken of or by me/him/her* in connection with the event can be used by the organisers for publicity or promotion without compensation to me/him/her*.

I acknowledge that I have read and fully understand the terms of this agreement. I have signed this agreement freely and voluntarily without any inducement or assurance of any nature and intend it to constitute a full and unconditional indemnity. Any provision contained in this agreement which is held to be held invalid shall be severable from the agreement and shall not affect the validity of the remaining provisions of the agreement.
